Regents' Policy 10.02.070. - Accreditation. (additions and deletions in red)

- A. The University of Alaska Anchorage, the University of Alaska Fairbanks, and the University of Alaska Southeast, emmunity colleges, if established, will each, based on its own merits and the quality of its programs, seek and maintain accreditation from the Northwest Commission on Colleges and Universities. Chancellors are responsible and accountable for instituting a robust process for maintaining accreditation at their university.
- B. Individual program accreditation by professional accreditin g bodies should be sought when meeting such accreditation standards is consistent with the goals of the university.
- C. Annually, the president, in coordination with the chancellor of each university, shall provide a written report to the Board of Regents' Academic and Student Affairs Committee on the status of institutional and specialized accreditation. As necessary, the president will brief the board on emerging issues of concern regarding accreditation status.
- 1. The report must summarize the university's status within the Northwest Commission on Colleges and Universities 7-yea review cycle including progress made in addr essing any recommendations from the commission.
- 2. For each program with specialized accreditation, the report must provide the following information: the college or campus
