REGENTS' POLICY

PART II – ADMINISTRATION

Chapter 01.01 – Officers of the University

PO2.02.010. Academic Administration.

A. The president will PROMOTE be responsible for the efficient and effective operation and management of the university SYSTEM educational programs AND FACILITATE COOPERATION AND COLLABORATION ACROSS THE SYSTEM. The president will recommend the structure of the academic administration to be established by the board. The president will approve the appointment of the academic officers and faculty of the university SYSTEM unless such responsibility is delegated elsewhere in regents' policy or university regulation.

PO2.02.015. Chancellors. There are created the positions of Chancellor of the University of Alaska Anchorage, Chancellor of the University of Alaska Fairbanks, and Chancellor of the University of Alaska Southeast, who will be appointed by and report to the president AND THE BOARD OF REGENTS. Chancellors will be the chief executive officers of the unit for which the chancellor is appointed and will perform THE FOLLOWING DUTIES such—RS

WILL BE RESPONSIBLE FOR THE EFFICIENT OPERATION AND MANAGEMENT OF THEIR UNIVERSITIES, INCLUDING EDUCATIONAL PROGRAMS, EMPLOYEES, FACILITIES, FINANCES, PROPERTY, STUDENTS AND RESEARCH ACTIVITIES; AND WILL FULLY INFORM THE BOARD AND THE PRESIDENT IN A TIMELY FASHION OF ANY MATTER WHICH MAY MATERIALLY AFFECT THE ABILITY OF THEIR RESPECTIVE UNIVERSITIES TO MEET THEIR MISSIONS AND OBLIGATIONS. IN FULFILLING THESE RESPONSIBILITIES, THE CHANCELLORS ARE AUTHORIZED TO TAKE SUCH ACTIONS AS MAY BE NECESSARY TO IMPLEMENT THE POLICIES OF THE BOARD INCLUDING, BUT NOT LIMITED TO, THE EXECUTION OF DOCUMENTS AND THE APPOINTMENT, SUPERVISION AND TERMINATION OF EMPLOYEES.

CHANCELLORS WILL HAVE AUTHORITY OVER AND BE RESPONSIBLE FOR POSITIONS AND ISSUES THAT RELATE DIRECTLY TO THE REQUIREMENTS OF STATE, FEDERAL, AND REGIONAL AGENCIES, ACCREDITING BODIES, OVERSIGHT ORGANIZATIONS, AND OTHER GOVERNING BODIES WITH REGARDS TO THEIR UNIVERSITIES.
